**SUBJECT:** Public Hearing on Proposed County of Orange Commercial Cannabis Activities and Outdoor Personal Cultivation Prohibition Ordinance

**PROPOSAL:** Authorize initiation of Zoning Code Amendment CA 17-02 to prohibit commercial cannabis activities and outdoor personal cultivation of cannabis. Recommend adoption of Zoning Code Amendment CA 17-02 by the Board of Supervisors that will add Section 7-9-146.14 "Commercial Cannabis Activities and Outdoor Personal Cultivation Prohibition Ordinance" to the Zoning Code which will prohibit commercial cannabis activities, including distribution, commercial cultivation, delivery, manufacturing, and testing, and outdoor personal cultivation.

**APPLICANT:** OC Development Services
